

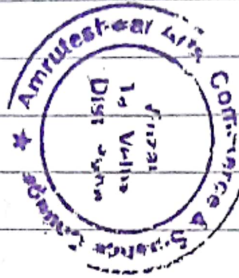
3. Regarding the matter of grievance complaint it was found that there is no such complaint during the academic session. Hence redressal is nil.
